- 1) Sir Knights' Registration: 7/16/21 - 9:00 - 5.00p.m. & 7/17/21
- 2) The Official Supreme General Assembly Conclave Opening Session will be Saturday, July 17, 2021 Conclave will begin on time. Each Sir Knight of this Conclave is reminded of their obligation to attend all meetings pertaining to the Conclave Session and to be punctual.
- 3) Each Sir Knight and/or State/National Officer (s) entering Conclave late will be fined (**\$2.00**) two dollars. The proceeds will be added to the Greetings to the Gracious Ladies' collection.
- 4) Each Sir Knight and/or National Officer (s) entering Conclave must be properly attired. Proper attire will be defined as a shirt with a collar with slacks/pants. No hats with brims or crowns are allowed in the meeting chamber, unless they are worn for medical reasons.
- 5) All cellular phones and pagers are to be turned "**OFF**" or placed onto the "**VIBRATE**" position before entering into Conclave. Each Sir Knight that has their cell phone ringing in Conclave will be fined (**\$2.00**) two dollars. The proceeds will be added to the Greetings to the Gracious Ladies' collection.
- 6) There will be **NO SMOKING** in the conclave. No Food, No Alcoholic Beverages are to be brought into Conclave. Water, Coffee, Juice, etc., is, however, permissible.
- 7) Each Sir Knight within Conclave must obtain the floor (have the right to speak) having been recognized by the chair, will go to the microphone and speak. Each Sir Knight will give their name, assembly number, city and state, upon reaching the microphone. Raising your hand means nothing and standing while another has the floor is out of order!
- 8) Each speaker will be limited to (2) two minutes on any question and/or comment, with a (1) one minute follow up rebuttal. After the speaker has made the question and/or comment, they are no longer allowed to speak. No motion is debatable until it has been duly seconded and stated by the Chair. Supreme Officer's Nominations and Election Process

Nominations and election of Supreme General Assembly Officers shall be held at the designated time indicated by the Presiding Officer according to the Conclave Agenda.

Officers to be elected are as follows: Most Faithful Navigator, Very Faithful Captain, Very Faithful Comptroller, Very Faithful Purser, Very Faithful Scribe, Very Faithful Steward,

Very Faithful Pilot, Very Faithful Inner Sentinel, and Very Faithful Outer Sentinel. All candidates for office must be present in the Conclave Chamber to be placed in nomination.

Sir Knights desiring to make nominations should approach the microphone, show their voting card, be recognized, and give his name and Assembly number before making their nomination. Nominating speeches shall not exceed two minute. The Timekeeper will be a member of the Nominations and Election Committee. Sir Knights nominating a person for office must cease speaking when time is called by the Timekeeper.

A nomination form will be provided by a member of the Nominations and Election Committee. The form must be completed in order to have the correct office and correct spelling of the candidate's name for placement on the official ballot.

Seconds to each nomination will not be necessary. An individual may nominate himself for a Supreme General Assembly office.

Once all nominations for each office are completed, the candidates will be introduced to the membership present in the Conclave Chamber.

Sir Knights will be given instructions by the Nominations and Election Committee Chairperson and/or Presiding Officer when balloting will begin, to facilitate an orderly movement of the membership to the designated voting area.

Sir Knights will gain admission to the voting chamber by showing their voting card as appropriate identification. After signing the official register and their voting card, each Sir Knight will be provided an ELECTOR ID and PASSWORD. The Sir Knight shall then proceed to the assigned computer to cast his secret ballot. After balloting is complete, the ELECTOR ID and PASSWORD will be deposited in the sealed receptacle provided. We ask your cooperation to allow our current Supreme General Assembly officers to enter the voting chamber and allow them to vote, at any time, during the allotted voting time, in order that they may continue their duties as officers during this Supreme General Conclave meeting.

All officers will be elected by a majority of votes cast for each office. In the case of no clear majority, the names of the two candidates with the largest number of votes will be resubmitted to the membership for a vote to determine a winner.

All officers will be elected by a majority of votes cast for each office. In the case of no clear majority, the names of the two candidates with the largest number of votes will be resubmitted to the membership for a vote to determine a winner.

The report of the results from the Nominations and Election Committee shall be placed on the Conclave Agenda for early in the Afternoon Session to allow adequate time for run-offs, if necessary. If a runoff of candidates is indicated, instructions will be provided at that time.

Certified tally sheets of the electronic election results will be provided by the Nominations and Election Committee to the National Conclave Scribe, so that they can be included in the 2021 Supreme General Conclave Minutes and retained for 30 days following the election of officers.

Campaign paraphernalia may not be worn or displayed in any manner or form once the Election process begins, inside the Conclave Chamber or in the designated voting chamber. The Election process shall begin upon approval of the Guidelines for the Nomination and Election Process by the 2021 Supreme General Conclave body.

The Nominations and Election Committee shall monitor all phases of the election process.
